Margo Perkins opened the meeting at 2:02 p.m. which took place online, using Zoom.

I. Curriculum Reports — Margo Perkins

Margo Perkins stated there were no new courses or additional sites/sections of existing courses, this month. Next, Margo discussed the "12 Elements of a High-Quality Program," found in our ROP Course Development guide, which districts should be referencing as they develop any new courses.

II. Finance/Legislation/Other — Janet Sloan

Janet Sloan began by discussing legislation in Sacramento, including AB 2573 which is a bill concerning tenure for teachers, including CTE instructors. This bill is supported by California Teachers Association but opposed by many educational agencies. Another bill, AB 2058, would redirect funds for the K-12 Strong Workforce Program away from the state's community colleges and be combined with CTEIG funding for distribution.

Janet discussed a recently discovered piece of legislation which was attached to last summer's trailer bill (AB 130) and affects the majority of our Community Classroom contracts. The language in the bill requires outside vendors providing contracted services for schools to fingerprint any employees who may come in contact—either in-person or online—with California students. This means all currently active and future Community Classroom contracts districts submit must provide verification from business partners that they meet this new requirement. It's believed this legislation was enacted to deal with other issues concerning the safety of students but had an unintended consequence toward our Community Classroom experiences. Janet has been contacting multiple people and agencies regarding this legislation and is attempting to find a way to have our Community Classroom contracts exempted from this new law. The only exceptions to this requirement are for those pathways which have our instructors supervising onsite with their students, such as the CNA and Careers in Education classes. More information will be shared soon, as we get additional direction from our legal department and the state.

Janet reminded District Coordinators that Friday, March 4, is the deadline to upload their data from the Follow-up Study we conducted in January to the CDE website.

Finally, Janet discussed 2021-22 CTEIG funding. Although our consortium did receive \$2.76 million in funding, it wasn't the anticipated \$3.3 million we had requested, and fell short of the match our districts had proposed. We will be discussing this issue with Senator O'Donnell, as well as the State Board of Education. Final approval for CTEIG funding from the Board is expected March 10, 2022. Once approved, Janet will send out MOUs and funding charts to the districts in our consortium.

III. Financial Update — Teresa Schneider

Teresa Schneider had no new updates for our District Coordinators, this month.

IV. Follow-up Study — Janet Sloan

Janet Sloan reviewed the results of this year's Follow-up Study which were good. However, there were some issues with disconnected phone numbers and some people refusing to speak with our staff. Next school year, we plan to start making contact earlier—possibly in November—by sending out a text message with a survey link. Following that, we will compile a list of non-respondents and begin calling those people in January 2023.

V. K12 SWP Pathway Specialists Report — Kenny Lopez/Michelle Wong

Michelle Wong shared an update they received from Fresno State stating they had 25 courses submitted for Uni-track approval, and there should be more information to share next month.

VI. Advisory Night Review/Advisory Committee Meetings — Mike McColm

Mike McColm stated the updated template for spring advisory meetings was now available online through the Attendance website. All instructors should have received an email regarding host/recorder duties for our Spring Advisory Night, as well as a reminder of the number of advisors required to be in attendance. Registration for the event—scheduled for April 26, 2022, at Clovis North High School—is now open on the Attendance website, with a deadline of April 8, 2022. Please remind instructors planning to attend to register themselves, as well as their advisors who will be participating.

VII. Designated Subjects CTE Credential — Margo Perkins

Margo Perkins reminded District Coordinators to verify a potential instructor's specific work experience related to any CTE positions they're filling, and not just the fact they have a credential in that subject. Also, Margo will be participating in a CTE credential advisory meeting on April 28, where attendees will share about their programs, any updates and receive feedback.

VIII. Events Update — Anthony Ayerza & Mike McColm

Anthony Ayerza shared the upcoming schedule for this year's Career Skills Challenge. Most of the competitions will take place in-person on various dates and at several host sites, beginning at the end of March and continuing into April. Some competitions will remain virtual, this year. Most of the award medals will be presented at the in-person events, once the competition is completed and judged. A virtual awards presentation will take place, via Zoom, on May 5, 2022, announcing the winners of the individual events, along with the overall school winner. (There will not be any division winners, this year.) Materials including all the important information for Career Skills Challenge, as well as registration links, will be emailed to instructors, and District Coordinators are asked to follow-up with their staff.

Anthony announced Career Tech Expo has been confirmed for the next school year and will return to Chukchansi Park in downtown Fresno on October 19, 2022.

Anthony stated there will be 2 one-week sessions of our Tiny House Workshop taking place in June 2022. This training is available to all construction instructors and registration is now open.

Anthony introduced new Onshape training courses to be held online for our welding and construction instructors, scheduled for May 2022. Janet purchased Onshape software licenses for all of our schools, last year, and it has been well received.

Additionally, Mike McColm discussed the non-profit group Junior Achievement which is presenting the upcoming JA STEM Week from March 8-11, 2022. This event showcases JA partners through a four-day event that brings workshops, mentors and speakers together to inspire students through virtual learning experiences. A flyer with more information and a registration link was attached to the agenda. Please contact Mike or Anthony for more information.

IX. Attendance — Margo Perkins

Margo Perkins reminded District Coordinators that attendance information is due March 18, 2022. Also, for districts offering adult school programs through us, attendance information must be reported on a weekly basis. Please contact Jackie Franz with any questions.

X. Other

Mike McColm stated two of our districts were interested in creating an “a-g” welding course and invited instructors from other districts to participate in developing this course. Please contact Mike, for more information.

Janet Sloan mentioned the CTE conference held every November in Southern California is returning. This is a great opportunity for districts to make presentations. Also, ACTE has made a call for presenters for their next national convention taking place in Las Vegas in December.

The meeting was adjourned at 2:43 p.m.
