Margo Perkins opened the meeting at 2:03 p.m which took place online, using Zoom.

I. Curriculum Reports — Margo Perkins

Margo Perkins stated there were no new courses or additional sites/sections to discuss.

II. Finance/Legislation/Other — Janet Sloan

Janet Sloan discussed the recent CTEIG submission deadline and suggested improvements to our consortium’s application and more sit-down meetings with districts, before submitting next year’s application. Every January, our office submits a report to the state showing districts are spending down their CTEIG money and they have met their match in the fiscal year funds were awarded. In order to meet this obligation, Janet requested a report from districts, by the last Friday of January, showing 20-21 and 21-22 funds. Also, all 20-21 funds must be spent by December 31 of this year.

Janet mentioned there are many new legislators in Sacramento and CAROP will be focusing on educating them about CTE. More CAROP plans will be shared in the spring, following results of the midterm elections.

Teresa Schneider said she is working on getting the workbooks out to the districts.

III. K12 SWP — Kenny Lopez & Michelle Wong

Michelle Wong shared some information with District Coordinators in the Zoom Chat section. One of those items was K12 Strong Workforce survey for all districts to give feedback. Also, Michelle reminded everyone the SWP Request for Application deadline is October 14. Finally, for those districts already funded, Cal-PASS+ upload is due November 1.

IV. Credentials — Margo Perkins

Margo Perkins gave an update on the CTE Credentials program which has 56 participants signed up for the Foundations course. Our mentors have had their initial contact with the new instructors they're assigned to and should begin visiting campuses soon.

V. Career Tech Expo — Anthony Ayerza

Anthony Ayerza discussed the upcoming Career Tech Expo event being held at Chukchansi Park in downtown Fresno on October 19. Free parking is available across from the stadium at H Street and Inyo. Students should gather at the main entrance and gates will open at 5:00 p.m. Concessions will be available for participants. There are several student experiences planned for various career pathways throughout the day.

VI. Advisory Committee Meetings — Mike McColm

Mike McColm reminded District Coordinators that instructors have until December 16 to submit their fall Advisory Committee Meeting minutes and sign-in sheets to our office. Meetings should be held in-person this year and must have 3 advisors per instructor, in order to be valid. Also, nominations for the William F. Noli Awards are due January 9, 2023 but may be submitted anytime before then.

VII. Other

Margo Perkins mentioned several districts still have not enrolled their students through our Attendance website. Please check with your staff that this gets completed.

Attendance is due October 21, 2022 (for August & September). Students must be enrolled in our system, in order to document their attendance.

Margo announced a Call for Presentations to participate in this year's Educating for Careers Conference in Sacramento (February 26-28, 2023). The deadline for submitting presentation ideas is November 30, 2022.

All District Coordinators should have received an email from Will Betts with a list of their specific instructors who have expiring credentials. Please review and work with your instructors to update/renew their credentials.

Margo and Janet Sloan discussed the Educators Institute for Pathway Development Conference taking place in Southern California. Please refer to the attached handout, for details.
